To apply for a MCSF scholarship for seventy-five (75%) of the school tuition (maximum of \$1,400 per child, per year) follow these instructions:

- ❖ Application period begins January 1st of current year and ends April 30th of current year.
- To determine if you qualify financially for the grant refer to the chart at the bottom of this page.
- ❖ Fill out a separate application for each child in grades K through 12.
- ❖ Complete, sign and mail the Student Application Form to MCSF. Scholarship selection is on a random basis. Scholarship winners will be notified in July of current year.
- There is no need to re-apply every year. If you have applied in the past, call the MCSF office check on the status of the file. Do not apply twice for the same child.
- ❖ It is strictly up to the school whether they accept the child for enrollment
- ❖ After the MCSF offers you a scholarship and once the school has accepted your child(ren) the school will complete and return the School Commitment Form to MCSF.
